- 1. It is an essential condition for the customer to exercise the withdrawal that the integrity of the products to be returned is preserved. In particular, the products:
- must not have been used, worn, washed, ironed or damaged;
- the identification tag must still be attached to the products, as well as the various composition and washing labels;



- must be arranged in the original packaging and complete with all the accessories and elements present in the original packaging.
- 2. The customer will be responsible for the decrease in the value of the products resulting from handling other than that necessary to establish their duration, characteristics and functioning or in the absence of the elements or accessories present in the original packaging.
- **3.** The withdrawal does not apply to products that do not lend themselves to being returned for hygienic or health protection reasons.
- **4.** The products of the same order that are returned must be sent in a single shipment. Therefore, we reserve the right not to accept products belonging to the same order that have been returned at different times. The products must be returned duly packaged and packaged at the customer's expense, preferably using the delivery packaging.
